



INTRODUCTION

FAKE PANDEMIC AND COLLUSION? These two Interviews about the 2009 H1N1 "Pandemic" first appeared in French in the print edition of LaMétropole.com in February, 2010. They are brought to light today, and in English, courtesy of thereisnopandemic.net so that by comparison with the Sars-CoV-2 "pandemic" of today, hindsight may lead to rational conclusions and long overdue action today to protect individuals and align all of us in solidarity against the damage being wrought by our corrupt governments in the name of Big Pharma and globalist elites.

In every aspect, the so-called H1N1 "pandemic" of 2009-2010 was a dress-rehearsal for the Covid-19 scamdemic of today.

Under basically identical conditions, the "un-healthy" ties links of the World Health Organization to Big Pharma, and severely reduced criteria for declaring a "pandemic", hysteria has been generated that has led to mass-vaccine-deaths and millions of vaccine injuries.

Hysteria and fear are underscored by lies, prohibition of autopsies, the faking of death certificates and death statistics, and rampant re-labeling of colds and the flu as "Covid-19" to boost the death and "infection" figures. The fake PCR "test" has been added in 2020-2021 as the motor of false second and third "waves" declared as a pretext for lockdowns and used to back threats against the non-vaccinated. As with the H1N2 scam, mutations, now called

"variants" are pulled from a hat whenever more intimidation is required to clamp down on the lives and freedoms of nations and individuals.

The conscription of the mass media as uncritical cheer-leaders for the drug pushers allows Big Pharma's drug traffickers in our governments to peddle unneeded shots indebting our countries while enriching the pharmaceutical giants.

This time, for Covid-19, the perpetrators have padded "risk of death" as a ground to declare a pandemic, with "risk of contagion".

They now allege the virus is completely new, that no one has immunity. Moreover, they claim, it's highly contagious. However, lawyer Dr. Reiner Fuellmich and his medical, legal and scientific research team confirm that the alleged Sars-CoV-2 "novel" coronavirus is not new at all, many of its components have long been under patent (at least 73 patents); and there is no sign that any such virus ever escaped a lab or anywhere else to be circulating and causing human illness.

So, the fantasy of death risk, the fantasy of contagiousness, are nothing but a pretext for the pandemic window-dressing globally deployed of scientifically and medically unfounded cult-like practices of mask-wearing, neurotic hand-washing, social distancing, quarantines, lockdowns and isolation of individuals (bus drivers and grocery clerks, for example) behind plastic shields that in fact collect bacteria, spreading other contaminants. The only thing maintaining the illusion of any pandemic in place is the window-dressing. The only purpose of the window-dressing is mind control.

Today, the scamdemic has been escalated with vaccine passports to minutely monitor and control our daily lives. It has been used by members of the UNPA and the UNO to demand that the United Nations be converted into an "elected" world assembly, an official world government, basically a health dictatorship on the Red Chinese model (like the medically and scientifically unprecedented lockdowns which are also Red Chinese in origin, and are nothing but communist-style punishments administered to beat societies into compliance).

Only the pharmaceutical industry and globalist institutions benefit from the diluted pandemic criteria.

FAKE PANDEMIC AND COLLUSION?

Exclusive Interview with Dr. Alain Poirier

The global vaccination campaign against the A H1N1 flu of 2009-2010 was a world première. First, because of the rapidity with which the vaccines were developed, then for the sheer scope of the mass vaccination campaign, and finally for the controversy unleashed. In Quebec, nearly 60% of the population was vaccinated in record time. But, why such a monumental vaccination campaign? Have we not played the sorcerer's apprentice in using an insufficiently tested "magic potion" the risks of which have been evoked by the international community? A commission of inquiry has just been launched by the Parliament of the Council of Europe. Alain Poirier, National Director of Public Health, replies exclusively to La Métropole on some fundamental questions.

What was it that justified the exceptional public health measures that you undertook in the face of the A H1N1 flu?

The WHO (World Health Organization) said that it was a pandemic when the A (H1N1) flu emerged. What is a pandemic? It can start when someone who is carrying a virus transmits it to more than one other person. Multiple transmission is likely to create a wave. We had never fought a pandemic of this nature and of this scope in Quebec.

What convinced you of the scope of the pandemic risk?

The first wave of the pandemic arrived last April. Last Spring, this seemed quite disturbing. News from Mexico showed that it was a new virus for people under 50 years of age, although in nature it was the same as the 1957 virus. Only

people aged 50 and over had a little natural protection. It was the young population, typically less affected, that was implicated.

Some said that governments and the WHO were manipulated by pharmaceutical giants exaggerating the pandemic risks...

I never met the representatives of the [pharmaceutical] laboratories for the purpose of deciding to plan a vaccination campaign.

Was mass-vaccination the only solution back when there were not yet any vaccines in existence?

We saw how this virus has been fought elsewhere. We decided on a campaign of mass-vaccination according to our surveillance indicators, notably in the hospitals. When the epidemiological studies allowed us to recognize that the elements of a pandemic had been united. Which led us to decide to proceed to the vaccination campaign. There were 112 confirmed deaths from the virus in Quebec. It was therefore necessary to vaccinate the people. By vaccinating, we wished to limit cases of the illness amongst the population. We had to be ready. What was important was to make good decisions with qualified people. As national director of public health, I worked very hard with a high level of confidence in the institution. Our team was focused on the necessity of obtaining a vaccine.

Did the fact that the announced vaccine was prepared very rapidly and had not even been tested in Canada raise any doubts? What did you think of the anxiety exhibited by some of the population concerning the vaccine?

We did not put the safety of the population at risk. I understand peoples' concerns. The questions of security were legitimate. The vaccine had not been tested in Canada, but it had been tested elsewhere, like many other products. It was at the request of governments that the 30 world producers received the demand to prepare a vaccine to fight this new virus. It was at our request that Glaxo tested the effectiveness of the vaccine. Laboratory analyses were conducted in Canada for the initial cases, then after that the information was checked, and that was sufficient. It was not necessary to do more.

How can you guarantee us that these vaccines were safe? An adjuvant was added to most doses in order to increase the yield. Some researchers believe the principal adjuvant used, **squalene, would lead to little understood and dangerous allergic reactions. Others spoke about the risk of **Guillaine-Barre** syndrome, a neurological disorder linked to the vaccine, itself.**

Vaccination is a known procedure, this kind of product has existed for a long time. Vaccination is efficient and safe. You are asking me about the risks of adjuvants. An adjuvant makes the effects of the vaccine more rapid. It isn't necessary to revaccinate. Adjuvants come from nature and reinforce the production of the antibody. It's a good strategy to economize on the doses. The same technology was used as with seasonal flu vaccine. In 1997, in Europe, 47 million Europeans were inoculated with vaccines containing the same adjuvant. There were allergies, but not serious. The same rate of allergies was observed for H1N1 as for seasonal flu (vaccine).

Another subject of concern was the preservative, **Thiomersal, a mercury-based additive for vaccines against the risk of microbial contamination. This**

has been used a lot since the early 1930s, but the risks occasioned in patients caused its withdrawal in the United States in 1999. However, it was just used in the new vaccine...

The use of low-dosage mercury protects the vaccine. It is eliminated by the body in under 48 hours. It has been used in many vaccines for a long time. Risks associated with injection of this mercury have not been confirmed. The safety of this vaccine is such that, in all probability, the vaccine against the H1N1 virus **will be included in the seasonal flu vaccine** next winter, a decision that will be made this Spring.

What do you think of the public controversy in Europe? And of the Commission of inquiry launched by the European Council of Parliament which questions the inappropriate influence of the pharmaceutical industry on the World Health Organization?

We understand perfectly that the Europeans have decided on a parliamentary commission to obtain all the information. If a commission had to be launched here, we would give them the same information we have just given to you. We are not opposed to furnishing all possible information with a view to legitimate transparency.

QUEBEC: CHAMPION FEAR-MONGER

Exclusive Interview with Lina B. Moreco, Filmmaker

When the European Community instituted a commission of inquiry on possible collusion between the pharmaceutical companies and the World Health Organization, here in Quebec we asked ourselves about the validity of mass vaccination. **La Métropole** met Lina B. Moreco, filmmaker and author of the documentary *Silence on vaccine*. [Quiet! We're vaccinating.]

(INTERVIEWER) GÉRARD SAMET

You are aware of the statements of Doctor Alain Poirier, National Director of Public Health for Quebec. Do you believe, like Dr. Alain Poirier, that we were at risk for an H1N1 pandemic?

The real question is this: Why, in May 2009, did the WHO change the criteria defining a pandemic? The level of severity, of the risk of contagion or of death necessary to declare a pandemic, was reduced. The risk of death. Without the recent change in criteria, there would have been no pandemic recognized. It's on

the basis of this notion that countries urged their populations to be vaccinated. There would have been no uncalled-for global panic nor any multi-billion world-wide purchase of doses of vaccine and Tamiflu. Who exactly profits from spreading fear across the entire planet with these new standards of surveillance? We know it's no secret to anyone that there are representatives of the major pharmaceutical laboratories present at every major meeting of the WHO. Officially, they are there as observers. It's said that they have no role in decisions. However, level 6, initiated by the WHO, represents billions of dollars in vaccinations and in medication for the industry. Moreover, on that subject, **Dr. Wolfgang Wodarg**, a renowned international epidemiologist, denounces the "total absence of transparency" which places the "health affiliate" of the United Nations "under the decree of the pharmaceutical industry". Who's responsible? Those countries — and in particular the major powers — who, under cover of installing the best experts, quasi-systematically delegate their powers to specialists from the big labs.

Vaccines were produced on an emergency basis in response to the H1N1 flu. Do you think they were safe?

None of the vaccines were tested before use. All the vaccines for H1N1 are experimental. So, how is it possible, under these conditions, to know the long-term secondary effects of the vaccinations or the auto-immune illnesses that may result? The health authorities prefer to dismiss children and adults alike with this pat statement, so often repeated in the media: "There are no secondary effects, there is no scientific proof." This is untrue. There are a number of studies which demonstrate, for example, that **Thimerosal** is a toxic product that must be removed from all vaccines. All that **Thimerosal** does, in reality, is to allow the production of a vast amount of vaccine, rapidly and at least cost, and entirely at the expense of our health.

So, you don't think there was any particular urgency?

No. The figures continued to fall while all the while we were informed of hundreds of deaths. There were only 26 deaths in July in Mexico. That was the highest rate of mortality in July. As of October, we also knew that most of those afflicted with the H1N1 virus experienced no severe secondary effects. That same month, Saint Justine's Hospital for sick children in Montreal released a communiqué confirming **the virus was benign**. Nearly 90,000 people die every year in Quebec. There were 112 deaths in Quebec officially attributed to H1N1. But what was the pre-existing state of health of these people? **How many people died in Quebec after being vaccinated?** Dr. Poirier has nonetheless declared that there was an urgent need to act in Quebec and that he decided alone, and without being influenced, to launch the vaccination campaign.

If the WHO had not declared a level 6 pandemic, it is clear that Quebec would not have declared one, either. We are at the receiving end of what transpires at the WHO. We are not the masters of our own decisions. We should have been able, like our American neighbors, to question the decisions of the WHO and say NO. Quebec did not make any decisions independently. It followed the lead of other countries, and in doing so, it certainly went too far. The directors of public health are not obliged to meet with the management of the WHO. All was accomplished by communiqué. And this despite the information flowing in from all directions which put the very notion of the pandemic and the dangerous nature of the virus into question. He [Dr. Poirier] acted alone in **triggering a fear**

campaign, a sort of social psychosis, so that citizens would be vaccinated. The government announced a pandemic, that thousands of deaths were anticipated. They frightened us with the first wave, then the second, and finally a third, like a Christmas present. And as if that were not enough, **a devastating mutation of the virus was predicted!** At the same time, in the southern hemisphere, Australia and New Zealand did not vaccinate their populations over the winter period (which is summer where we are) because the vaccines were not available. And there was no pandemic in Australia or in New Zealand. And there you have a major indicator of the minor importance of the illness. In France, barely 5% of the population was vaccinated in December, attaining a rate of 8% in January 2010. Which means that about 60 million people were not vaccinated. And then, in the United States, just 12% of the population was vaccinated in December, rising to about 20% in January. Which is to say that right next door to us, more than 240 million people were not vaccinated. And in both cases, the epidemic diminished in intensity.

Do you oppose the decisions that were reached?

Yes. The government continued, in spite of everything, to spend money in the media to incite the population to be vaccinated. What was said about the cost was not true. The vaccine did not cost only \$8.00 a dose.
