The updated guidance includes a disturbing analysis regarding the safety of the mRNA COVID vaccines.

“This analysis found that there is an 84% increase in the relative incidence of cardiac-related death among males 18-39 years old within 28 days following mRNA vaccination.”

With immunity levels high in the population (natural or otherwise), “the benefit of vaccination is likely outweighed by this abnormally high risk of cardiac-related death among men in this age group.”

This guidance doesn’t apply to non-mRNA COVID vaccines.

For mRNA COVID vaccines, such as Pfizer and Moderna, “The State Surgeon General recommends against males aged 18 to 39 from receiving [them].”

Additionally, the department advises people with pre-existing heart conditions take extra caution when considering getting mRNA COVID vaccinated.

They hinted that public health departments have neglected or dismissed the safety concerns for too long.

“These are important findings that should be communicated to Floridians.”

Recently, [hundreds of doctors](#) declared a medical crisis due to the COVID vaccines.

“We, the medical doctors and scientists from all over the world, declare that there is an international medical crisis due to the diseases and deaths co-related to the administration of products known as “COVID-19 vaccines,” their joint [statement](#) states.

Last month, Denmark [stopped offering](#) the COVID vaccines to most people under the age of 50.
